## Resources for States Planning Initiatives to Support Healthy Marriages

There are a growing number of resources for state policymakers and program administrators who are interested in exploring initiatives to support healthy marriages in their state. Many of these resources can be accessed via the internet. The National Governors Association Center for Best Practices has compiled a list of key websites where states can access research about family formation issues, learn about what is going on in other states to support healthy marriages, review marriage education curricula, and identify technical assistance providers. In addition to the resources listed below, the NGA Center is available to provide governors and their staff with information and assistance on these issues.

### Research

There is a large body of research on family formation issues. Below is a list of organizations and government departments that conduct or sponsor research on family structure, trends and attitudes about marriage, and the benefits of marriage for children, as well as evaluations of programs to strengthen healthy marriages.

*Office of Planning, Research and Evaluation (OPRE)* serves as principal advisor to the Assistant Secretary for Children and Families, U.S. Department of Health and Human Services on increasing the effectiveness and efficiency of programs designed to improve the economic and social well-being of children and families. OPRE is responsible for all aspects of the collection, compilation, analysis, and dissemination of data on selected ACF programs. The OPRE site features research reports and evaluation of ACF programs, including programs to support healthy marriages.

*Building Strong Families (BSF)*, a project of Mathematica Policy Research Inc, is an initiative to develop and evaluate programs designed to help interested unwed parents achieve their aspirations for healthy marriage and a stable family life. The website provides information about about the progress of the evaluation and the kinds of services that are being tested. Materials will be available to the public, but over time, a password-protected Learning Community will also be supported for the BSF research sites and others directly involved in the evaluation. <http://www.buildingstrongfamilies.info/>

*Center for Law and Social Policy (CLASP)* is a national non-profit that works to improve the lives of low-income people. One key area of the Center's work is on Couples and Marriage Policy, which focuses on (1) helping more children grow up with their two biological, married parents whose relationship is healthy and (2) when this isn't possible, helping parents--whether unmarried, cohabiting, separated, divorced, or remarried--cooperate better in raising their children. <http://www.clasp.org/publications.php?id=6>

**The Fragile Families and Child Wellbeing Study**, also called "The Survey of New Parents," follows a birth cohort of (mostly) unwed parents and their children over a five-year period. The study provides information on the capabilities and relationships of unwed parents, as well as the effects of policies on family formation and child wellbeing. The website has links to published research briefs, city and national reports, and working papers. The Fragile Families and Child Wellbeing Study is a joint effort by Princeton University's Center for Research on Child Wellbeing and Columbia University's Social Indicators Survey Center. <http://crcw.princeton.edu/fragilefamilies/index.asp>

**The Healthy Marriage Initiative** under the U.S. Department of Health and Human Services Administration for Children and Families aims to help couples, who have chosen marriage for themselves, gain greater access to marriage education services that can help them acquire the skills and knowledge necessary to form and sustain a healthy marriage. **The Heritage Foundation** is a research and educational institute whose mission is to formulate and promote conservative public policies based on the principles of free enterprise, limited government, individual freedom, traditional American values, and a strong national defense. **Resource Center for Healthy Marriages** will soon be launched by the National Council on Family Relations. The resource center, funded by the U.S. Department of Health and Human Services Administration for Children and Families, will serve as a clearinghouse on best practices and other pertinent information. The center will evaluate and synthesize research on healthy marriage programs and develop products to help individuals and organizations create and implement marriage education initiatives. **MDRC** is a nonprofit, nonpartisan social policy research organization dedicated to learning what works to improve the well-being of low-income people. MDRC is leading the ACF-funded "Supporting Healthy Marriages" project, which is designed to inform program operators and policymakers of the most effective ways to help couples strengthen and maintain healthy marriages. **Commission on Marriage and Family Support Initiatives** replaced the Florida Commission on Responsible Fatherhood on July 1, 2003. The new commission assumes a broader approach to strengthening families by detailing comprehensive statewide strategies for Florida to promote safe, violence-free, substance-abuse-free, respectful, nurturing and responsible parenting; including connection or reconnection of responsible parents, both mothers and fathers, with their children.
